The Eligible Voluntary Income (EVI) criteria used to allocate membership bands is set out below.

Eligible Voluntary Income **excludes** any income received from: investments, endowments, trading & retail, grants from Trusts & Foundations, statutory & government funding, ticketed events, corporate sponsorship and corporate donations and **includes** income from: individual donations, Gift Aid, payroll giving, legacies, in memoriam donations, community fundraising, sponsored events, and staff fundraising.

Subscriptions and Gifts in Kind will be considered on a case by case basis.

New members receive discounted fees in the 1st year of joining. This can be either:

- a 20% discount applied to the standard fee **or**
- 15 months of membership for the price of 12.
